

TERMS & CONDITIONS

Participant Agreement

Definitions

Participant: Anyone participating in PEAK Athletics Training activities and/or operations.

1. Respect for Property & Equipment

Participant must:

- Treat all Facility equipment, furnishings, and property with care.
- Use equipment only for its intended purpose.
- Return all equipment to its proper location after use.
- Refrain from damaging, modifying, or misusing any equipment.
- Immediately report damaged or malfunctioning equipment to staff.
- Understand that intentional damage or negligent misuse may result in fees, suspension, or membership termination.

2. Respect for Other Participants & Tenants

Participant agrees to:

- Maintain appropriate noise levels and avoid disruptive behavior.
- Share space and equipment courteously, including time limits during peak hours.
- Not interfere with classes, training sessions, or private rentals in designated areas.
- Respect all other tenants, businesses, and individuals in the building or shared facility.
- Refrain from harassment, bullying, discriminatory actions, or inappropriate conduct.

3. Safety & Conduct

Participant agrees to:

- Use equipment responsibly and follow all safety instructions.
- Avoid unsafe, reckless, or dangerous behavior.
- Follow all posted rules, signage, and staff directions.
- Report accidents, injuries, or unsafe conditions immediately.
- Acknowledge that PEAK Athletics Training is not responsible for negligence or failure to follow safety guidelines.

4. Facility Access & Personal Belongings

Participant acknowledges:

- Access is permitted only during authorized class times, appointments, or open-gym hours.
- Remaining in the Facility or on the premises outside scheduled times is prohibited without written approval from an authorized PEAK staff member. (CEO)
- PEAK Athletics training and its affiliates have been permitted the use of restrooms in a shared facility space. Any other use of this shared space is strictly prohibited, including but not limited to loitering, congregating, etc. Respect the facilities and return immediately to the PEAK Athletics Training center.
- PEAK Athletics Training is not responsible for lost, stolen, or damaged personal items.
- Personal belongings must be stored in designated areas, not left on the floor or walkways.

5. Acceptable Behavior & Zero-Tolerance Policies

PEAK Athletics Training maintains a zero-tolerance policy for:

- Violence, threats, intimidation, or aggressive behavior
- Sexual harassment or inappropriate physical contact
- Vandalism, theft, or intentional property damage
- Possession of weapons or illegal substances
- Being under the influence of drugs or alcohol during training

Violations may result in immediate removal or membership termination without refund.

6. Membership, Payments & Liability

- No Walk-ins after your first free trial day without sign-up. Participant is required to sign up before attending classes.
- PEAK Athletics Training reserves the right to charge the credit card on file according to the billing cycle the Participant signed up for.
- Participant agrees to pay for the subscription until a formal cancellation by the Participant has been made.
- If the Participant cancels the subscription during the billing cycle, no refund will be issued for the remainder of the billing cycle. Upon cancellation, Participant will be responsible for any bill that was going to be due within 30 days.
- Participants participate at their own risk and acknowledge the inherent risks of physical activity.
- Participant agrees to sign required waivers before participating in activities.
- PEAK Athletics Training reserves the right to terminate Participant membership at any time for any reason.
